Dear Friends,



At a community event in 2003, John M. Trani, former CEO and Chairman of Stanley Works, Inc., met retired Saint Francis president, David D'Eramo, Ph.D., and current hospital board chairman, P. Anthony Giorgio, Ph.D. The three shared a common heritage, sense of humor, and commitment to community. When Dr. D'Eramo asked John to join the Foundation Board a few months later, he unequivocally accepted. Since then John has been a devoted donor by supporting the hospital's capital campaigns, special events and annual giving programs.

Tony Giorgio, chairman of the Hope & Healing Campaign, called on his dear friend to talk about the hospital's plan to expand and renovate cancer services. This appeal struck a chord with John. His sister Theresa died from ovarian cancer at the tender age of 13. His father had cancer of the larynx, had his voice

box removed, and eventually, passed away from lung cancer. So, in order to celebrate their lives and assist with the fight against cancer, he pledged \$1 million to the campaign. John stated, "I thought this would be a wonderful opportunity to honor my family and to help create an environment dedicated to healing. Saint Francis does wonderful work, and I am honored to be able to support them and my community."

The newly renovated inpatient oncology floor has been named the *John, Carmela and Theresa Trani Oncology Pavilion*. It includes 20 renovated single patient rooms with many comforts of home, a family waiting room, improved staff accommodations and two family hospitality suites. The Trani family gift will have a tremendous impact on the lives of many cancer patients and their families.


Karl realizes how important this campaign is to our patients, their families and our community. He has been touched by cancer and believes in order to treat this disease the hospital needs to have the most gifted

Saint Francis received a \$500,000 grant from the SBM Charitable Foundation, Inc., toward the hospital's Hope & Healing Campaign. The Foundation's gift will expand the Smilow Cancer Hospital Yale-New Haven at Saint Francis by creating a new cancer care site in Glastonbury. The new center will include expanded treatment services, easier access to medical oncology providers and support services, and chemotherapy treatment with onsite oncological pharmacy services.

In addition, the cancer care center will also provide navigation services for patients, diagnostic services, integrative medicine services, and supportive care services including survivorship programs.

Educational community outreach programs will be offered on prevention, screening, and early detection.

Doreen Downham, executive director of the SBM Charitable Foundation, stated, "The SBMCF is pleased to continue its ongoing support of Saint Francis Hospital and Medical Center. The expansion of cancer care services, via the Glastonbury site, fits well within our East of the Connecticut River funding focus. The convenience of the location and the wide range of services provided at the site will benefit East of the River oncology patients, as well as those in our other area communities."

Eileen Adams and her family came to know Saint Francis after she was diagnosed with advanced stage of glioblastoma.





In addition to the renovation of patient rooms, the nursing station areas, the conference room and a staff respite suite have been refurbished to better accommodate the myriad functions of the staff.

Vicevich Family Supports the New Margery Brennan Vicevich-Guyott Center for Lupus and Rheumatologic Disease

Saint Francis received a generous gift of \$1 million from Barbara Vicevich. Barbara is committed to honoring the legacy of her beloved mother by creating the *Margery Brennan Vicevich-Guyott Center for Lupus and Rheumatologic Disease*. This gift was inspired by her brother Jim, who was seeking a comprehensive program to help him and others suffering from lupus and other rheumatic diseases.

The Center will be the first of its kind in our region and will become a well-recognized resource for patients seeking treatment for these disorders. It will offer diagnostic clarity and guidance and consultation and referral services. Jim was misdiagnosed for many

years, delaying proper treatment. His primary caregiver, Dr. Michael Grey, chairman, department of medicine, is fully aware of how important this center will be for many patients and their families. He has worked closely with the Vicevich family and other patients to create an environment that will offer all the services necessary for their treatment in one location.

We are so grateful to Barbara for her vision, compassion and generosity. We would also like to thank Dr. Grey for introducing Barbara and the Vicevich family to the expert and compassionate care at Saint Francis and Mount Sinai.

Gawlicki Family Foundation Grant

The Gawlicki Family Foundation has granted Saint Francis \$109,000 to implement a home-based pulmonary rehabilitation program for at-risk patients with chronic obstructive pulmonary disease (COPD).

With this grant, Saint Francis and program director, Richard L. ZuWallack, M.D., will implement a program for pulmonary rehabilitation in the home for discharged COPD patients. The home-based rehabilitation intervention will be a mechanism for enhancing patient-caregiver communication, providing necessary education, teaching self-management strategies, and promoting exercise and physical activity. In addition, an important goal will be to get the patient to transition from home-based to center-based pulmonary rehabilitation for continued care.





IN MEMORIAM

Daniel P. O'Connell – 1941-2016

On July 9, 2016, our dear friend Daniel P. O'Connell died after a long battle with Glioblastoma. Dan was an inspiring and impassioned pillar of our hospital community, while having served on the Board of Directors of Saint Francis Care, Saint Francis Hospital and Medical Center, the Saint Francis Foundation and lastly as the Board Chair of Trinity Health Of New England. His counsel and astute business acumen were vital to the success and some of the greatest accomplishments of our organization.

As a young man, Dan pursued two career paths: Biblical Studies and Business. He was a eucharistic minister, lector, parish trustee, chairman of the Parish Financial Council, member of the Parish Council, recipient of the Saint Joseph Medal and a special award for service to the church on an archdiocesan level from the Most Reverend Henry J. Mansell, Archbishop Emeritus of Hartford. Dan was a Knight of Malta and founding member of the Malta House of Care, which provides free healthcare to the poor in Hartford. He taught Bible Study at Saint Augustine Parish in South Glastonbury for over 40 years. Dan received his MBA from the University of Connecticut in Storrs and worked his way up as United Technologies Corporate Director of Compensation and Benefits worldwide.

Dan and his wife Nancy passed on their intelligence, caring and pragmatism to their son, John. John's spirit of volunteerism began at an early age. He volunteered to be a lector in his parish church when he was in sixth grade. John's early love of languages prompted him to take up the study of French and Russian beginning in sixth grade. He was accepted at Bates College in Maine, majoring in Russian and French. John spent time living in Novgorod, Russia, and in Siberia.

During the summer following his freshman year at Bates, John was accepted as the only college student into the Middlebury College foreign language study program in French. As a requirement, one has to speak the language of study, no English, to remain on campus. After graduating from Bates, John's ambition was to acquire his Ph.D. in Russian, obtain a diplomatic passport and become the U.S. Ambassador to Russia. Unfortunately, he was stricken with

Ewing's sarcoma, an aggressive form of bone cancer that took his life at age 20.

Nancy and Dan turned this horrible tragedy into an opportunity to give back to Saint Francis in recognition of the care and compassion shown to John. Their volunteer responsibilities included Dan sharing with family practice residents how best to care for terminally ill patients. Nancy, also a Eucharistic Minister, spent time sitting with and consoling cancer patients. In addition to their volunteering, they also sponsored two monumental gifts. They created and funded the John T. O'Connell Clinical Cancer Research Fund and then bequeathed \$5 million to finance the John T. O'Connell Tower.

The presence of the O'Connell family at Saint Francis continues to have a profound impact on our spirit. Their strength serves as inspiration. Their thoughtfulness brings many smiles and touches many. They will always be remembered.


