## Maximilian E. and Marion O. Hoffman Foundation FAMILY FOUNDATION

Family Foundations work together to have a meaningful and measurable impact on social problems. They also have a unique purpose...to serve as a unified vehicle for multiple generations.

The Maximilian E. and Marion O. Hoffman Foundation Inc. in West Hartford, Connecticut, was established in 1982 by Marion Hoffman in memory of her husband. The organization's mission is to donate to nonprofits that further education, medicine and the arts. Since 1990, the Foundation has generously granted over \$9 million to Saint Francis Hospital. Marion Barrak, niece of Marion Hoffman, assumed the role as president and CEO of the Foundation in 2006. Her father, Dr. Bahij Chaho, was affiliated with

Saint Francis Hospital and her husband, Dr. Bechara Barrak, has been an internist at the hospital since 1992. When Marion was asked why they continue to support Saint Francis Hospital, she stated, "Our initial grant of \$2 million was used to establish the Hoffman Heart Institute, the first comprehensive heart institute in southern New England. Since then, the level of care and compassion for the patients has never wavered, and we are grateful to be partners with an organization with such values."

This year, the Maximilian E. & Marion O. Hoffman Foundation awarded Saint Francis Hospital a \$1M gift to renovate the Congestive Heart Failure Unit. The newly renovated unit will be named the "Maximilian E. & Marion O. Hoffman Congestive Heart Failure Pavilion." Congestive heart failure is the leading cause of hospitalization in people over age 65. Annually, Saint Francis Hospital serves over 2,000 patients in the Congestive Heart Failure Unit and this number continues to rise each year. The new center will incorporate prevention, wellness, and rehabilitation services along with top specialists and state-of-the-art technology. Research has shown that hospital environments have a positive or negative effect on healing. The unit will have private rooms, calming environments, and other amenities that enhance the emotional support patients receive. Saint Francis Hospital is thrilled to be able to utilize these funds as a means to create a new, soothing, and comfortable environment for its congestive heart failure patients to complement the medical care our patients receive while they are hospitalized.

Saint Francis Hospital received a \$1 million, multi-year grant from the Coverys Community Healthcare Foundation (CCHF) to



partner with the Connecticut Surgical Quality Collaborative (CtSQC), an unprecedented coalition of all 29 Connecticut hospitals. This is the first coalition in the history of healthcare in Connecticut that brings together the best surgical teams in the state to share patient safety protocols, evidence-based surgical procedures and innovations. The goal of CtSQC is to eliminate errors during the perioperative process that result in unintended, adverse patient outcomes. This includes using evidence-based protocols to avoid errors before surgery, during surgery and during the transfer of patients to other multidisciplinary teams. The funding from Coverys has led to a significant amount of patient safety training throughout the state. This has resulted in better patient outcomes and a decrease in the number of adverse events at our hospitals.

## Community Foundation of Western Massachusetts DONOR-ADVISED FUND

Creating a donor-advised fund provides an opportunity for a donor to play an active role in determining which charities and programs their fund will support.

Founded in 1991, the Community Foundation of Western Massachusetts administers a charitable endowment

consisting of nearly 600 separately identified funds serving the three counties bordering the Connecticut River in western Massachusetts (Hampden, Hampshire, and Franklin Counties). Each fund was

contributed by one or more generous donors who wished to make a difference, on a local scale, in those communities. They make it possible for good people to accomplish good works in the Pioneer Valley. In addition, some of these charitable assets are unrestricted, used to meet emerging and changing needs or restricted to support named charities. Two such funds were created to support Johnson Memorial Hospital (JMH). The Virginia and Earl Jahn

> Fund was established initially as a donor advised fund, from which the Jahns would make recommendations for disbursement to JMH. Upon their passing, the fund became endowed to various organizations of their

preference while alive, and we are grateful JMH is one of those organizations. The Johnson Memorial Hospital Fund was establish in 2011 for specific capital projects necessary to better serve the patients of JMH and annual distributions are made to the hospital. Over the years, both funds have given more than \$100,000 to the hospital, and this year, their \$25,000 gift will assist with the purchase of a 3D mammography machine.

### Pink Aid and the Karl. J. Krapek, Sr. Comprehensive Women's Health Center at Saint Francis GRANT

Grants are awarded by corporations and philanthropic foundations to nonprofit entities. Most grants are made to fund a specific project or program and require extensive compliance and reporting. Grants are a vital part of the Foundation's fundraising efforts and can mean the continuation of and enhancement of many programs throughout the hospital. Each year we apply for 40 to 50 grants and receive over \$1M annually in grant funding. We are grateful to Pink Aid for their support and for more than \$125,000 to fund medical services provided by our Karl J. Krapek, Sr. Comprehensive Women's Health Center.

Saint Francis Hospital has been a partner with Pink Aid since their beginning. Founded in 2014, Pink Aid's mission is to help underserved, underinsured and uninsured Connecticut women survive breast cancer diagnosis and treatment with support and dignity. Pink Aid funds pay for diagnostic procedures to women in financial need whose mammogram indicated the need for further tests. When a woman is diagnosed with breast cancer, she needs a lot more than medical help. With a staggeringly high rate of breast cancer occurrence in Connecticut, there are countless women who cannot afford to go through treatment or to pay for daily living expenses because of their diagnosis.

In the past year, with Pink Aid's help, Saint Francis Hospital provided screening/diagnostic services to 31 underserved women. Another 61 women, who were undergoing treatment for breast cancer or were recovering from breast cancer, received 165 therapeutic sessions from Saint Francis' Integrative Medicine Department. The Integrative Medicine treatments reduce women's anxiety, pain, and stress. We are grateful to work with an organization like Pink Aid that shares our mission of making a real difference in the lives of women and their families in Saint Francis Hospital's service area. Together, Saint Francis Hospital and Pink Aid provide medical and emotional care with compassion and expertise.

## Patricia and Patrick Kinney PLANNED GIFT

A planned gift is a contribution that is arranged in the present and allocated at a future date. Commonly donated through a will or trust, planned gifts are most often granted once the donor has passed away. In 1997 Saint Francis Hospital celebrated its 100th anniversary and created The Valencia Society, named for the first hospital administrator, Mother Ann Valencia. The planned giving society was established to honor individuals who have left a planned gift to Saint Francis Hospital and Mount Sinai Rehabilitation Hospital. Such gifts might include bequests of life insurance, charitable gift annuities, charitable remainder unitrusts, or charitable remainder annuity trusts.

## Saint John's Bible

The Saint John's Bible is the first handcrafted Bible to be commissioned in 500 years. A team of artists coordinated by Donald Jackson in Wales and a team of scholars in Central Minnesota used the ancient techniques of calligraphy and illumination to create this seven volume masterpiece of art and biblical scholarship. It took the team more than a decade to complete. Trinity Health Of New England has been chosen as a pilot organization to share the Heritage Edition of the Saint John's Bible as a means to enhance the healing environment.

In 2019, dozens of donors helped raise \$300,000 to bring the Saint John's Bible to our healthcare ministry. On a daily basis, these beautiful bibles are brought to patients' rooms, colleagues' departments and community events to inspire and heal.
