The Garthwait's gift enabled the hospital to create a state-of-the-art cardiac monitoring system so all patients' heart activity could be monitored in one place, by a team of technicians. Together Effect Campaign – Saint Mary's Hospital The Archdiocese of Hartford

The Archdiocese of Hartford has committed \$250,000 to Saint Mary's Hospital to support the "Together Effect Campaign," a fundraising effort to support the advancement of several key areas of the hospital. The next phase will include advancements to our Emergency Department (ED). Saint Mary's ED sees more than 75,000 patients each year in a facility that was designed to accommodate half that amount. This generous gift will support efforts to assess, design, and reconfigure the ED to become the most advanced care facility in the community. The reimagined Emergency Department will provide a therapeutic environment that respects and accommodates all patient populations and care needs.

The Promise Campaign – Johnson Memorial Hospital **CAMPAIGN GIFTS**

The Promise Campaign has raised almost \$12 million of its \$15 million goal for the expansion and renovation of several areas on the Enfield Campus and within the main hospital. In Enfield, Johnson Memorial Hospital will create a world-class, state-of-the-art facility newly named the S. Prestley and Helen Blake Ambulatory Care Center. In addition, the improvements will expand the current Karen Davis Kryznowek Cancer Center and upgrade parking and the grounds. Within the hospital, construction is already underway for the geriatric wellness pavilion — slated to open by the beginning of 2022 and soon, senior emergency treatment protocols will be established within the Emergency Department.

Third Party Event – Saint Mary's Hospital GRATEFUL FAMILY

Since the onset of the pandemic in early 2020, over 1,440 patients with COVID-19 have come through the doors of Saint Mary's Hospital. Sadly, 279 of those individuals passed away from the disease, a stark reminder of the wide ripple effect the virus has had on so many community members who continue to grieve the loss of loved ones and family members.



During the height of the pandemic, there was a "no visitor" policy — a difficult step in order to keep everyone safe. The

physicians, nurses, and clinical staff did the best they could to communicate with families about their loved one's condition. That effort made such a difference for families. One family in particular was truly moved by the thoughtfulness and care of the clinical colleagues who watched over their beloved family member. Sadly, she passed away in the ICU in December 2020.

Although devastated by their loss, the family was profoundly touched by the exceptional and compassionate care she received at Saint Mary's Hospital. They spoke of how grateful they were to receive thorough updates every day from the doctors and nurses. During a celebration of life service for their loved one, the family accepted donations in her memory. The family came to Saint Mary's to personally thank the colleagues and present them with gifts.

Gawlicki Family Foundation – Saint Francis Hospital GRANT

Most people are aware that heart attacks and cancer are serious medical threats but awareness of COPD, Chronic Obstructive Pulmonary Disease — the third most important cause of death in the US — is not nearly as well-known. For anyone who has struggled to breathe, finding effective treatment options is the difference between suffering through life and enjoying it to its fullest.

As a patient with restrictive lung disease which limits her physical abilities in similar ways to COPD, Mary Gawlicki was both amazed and pleasantly surprised at the positive effects she realized from participating in the pulmonary rehabilitation program at Saint Francis Hospital. She learned valuable techniques for controlling her breathing and was able to learn tricks that other participants had developed to manage their lung disease. Mary advised, "When you add technical experience to the availability of the knowledgeable and caring providers at Saint Francis, there is no other single program that was as helpful in managing my pulmonary restrictions."

The Gawlicki Family Foundation was established in 2012 by Ted and Mary Gawlicki, and since its inception they have awarded nearly \$7 million to over 30 organizations, upholding their belief that private dollars power public progress. They have committed more than \$300,000 in grants to support pulmonary rehabilitation programs offered at Saint Francis Hospital. Mary participates in an on-line pulmonary rehab program several times a week, and while she misses the camaraderie of the hospital's in-person offering, she and Ted look forward to continuing their support of the program.

Anonymous Gift – Mercy Medical Center FOUNDATION GRANT

Mercy Medical Center has been awarded a \$115,000 anonymous grant to create a "recharge room" to help medical workers recover from pandemic stress. The pandemic has taken a significant physical and emotional toll on medical workers. Frontline staff have witnessed an unfathomable amount of death, suffering, and grief. With this grant, Mercy Medical Center was able to partner with Studio Elsewhere to design a break space with multisensory, natural elements to help staff relax and recharge.

These rooms are designed to promote a sense of safety, calm thinking, empowerment, connectedness, and hope. Through an immersive experience that includes music, scent, visuals, lighting, and sound, colleagues are transported to a preferred environment such as a twilight lake, serenity beach, or redwood forest. The space is customizable, allowing coordination of sounds, sights, and smells based on mood. Research shows that integrating natural elements into interior spaces is beneficial for health and well-being and can significantly reduce stress levels and increase control resulting in less need for pain medication, fewer doctor errors, better sleep, and improved outcomes.

American Savings Foundation – Saint Mary's Hospital FOUNDATION GRANT

American Savings Foundation is a permanent charitable endowment established in 1995 by American Savings Bank, in hopes of giving back to the 64 Connecticut communities they served for more than 140 years. They are dedicated to strengthening these communities and believe in the positive connection between good business practices and corporate social responsibility. To date, the Foundation has contributed over \$64 million in grants to local nonprofit organizations and college scholarships to area students.



Saint Mary's Hospital was honored with a \$50,000 grant from the Foundation to support the hospital's Together Effect Campaign. This gift will help to transform the Emergency Department (ED), which is led by a highly skilled, multilingual team providing round-the-clock care with a Level II Trauma Center and a cardiac care environment recognized by the American Heart Association for quality.

The hospital is committed to doing all it can to alleviate the stress, anxiety, and fear experienced by patients in a medical emergency. With an increased footprint, additional seating and built-in conveniences, and new floorplan, the reimagined ED will provide a therapeutic environment that respects and accommodates all patient populations and care needs. Currently, more than 75,000 patients are seen in the ED each year, and the plans will also increase the number of patient rooms, provide space for new equipment, make improvements to the geriatric and pediatric environments, and enlarge the behavioral health ED including a separate entrance.

Connecticut Health Foundation – Saint Mary's Hospital FOUNDATION GRANT

The Connecticut Health Foundation is the state's largest independent health philanthropic organization dedicated to improving health outcomes for people of color. Since its creation in 1999, the foundation has awarded more than \$69 million to nonprofit organizations and public entities to expand health equity, reduce health disparities, expand health coverage, and improve the health of all Connecticut residents.



Saint Mary's Hospital received an \$80,000 grant from the Connecticut Health Foundation to pilot ways to better identify and address patients' social care needs. Much of what influences health happens outside the medical care system, but issues such as whether a patient has enough to eat, a safe place to live, or reliable transportation are not typically noted in medical records or addressed during visits.

The Saint Mary's Hospital Emergency Department, family clinics, and outreach programs are implementing a screening and referral system for social factors that influence health. Patients who need extra support are being referred to a community health worker and connected to community resources through an electronic system that allows clinicians and caseworkers to ensure patients receive support and to track their outcomes. This significant work to help reduce health disparities is a priority for all Trinity Health hospitals.

Bombas and Southington High School – Mount Sinai Rehabilitation Hospital **CORPORATE AND COMMUNITY SUPPORT**

Mount Sinai Rehabilitation Hospital offers both inpatient and outpatient services for patients with complex cases such as traumatic brain injury, multiple sclerosis, spinal cord injury, stroke, orthopedic and neurological rehab, trauma, and cancer. Patients benefit from a coordinated approach to rehabilitation medicine and their treatment is individually tailored to maximize independence for return to their community. However, they don't always have the appropriate tools they need to participate in therapy. It has been proven that good footwear is essential for exercise and therapy.

To fill the gap, each year a sneaker drive is held to accept new or gently used sneakers for male and female patients. The Southington High School Track Team answered the call and

collected more than 60 pairs of sneakers. The kids were so excited at their success that the team promised to host an annual drive. And what goes best with sneakers? Socks — also something that patients don't always have. So, five years ago Bombas was approached to ask if they would provide socks for our patients. Their answer was an immediate yes and to date they have donated more than 13,000 pairs of socks. These donations have not only assisted our patients but have allowed us to share them with many of our community partners such as, Unity Plaza Pantry, Hartford Bags of Love, Joan C. Dauber Food Pantry, Veterans and Military Service members attending The CT Adaptive Rowing Program and golfers participating in the adaptive Golfers in Motion Program. These efforts make our communities better and our patients stronger.

JoAnn Price – Trinity Health Of New England BOARD GIFT

As eligibility for the COVID-19 vaccine opened up in Connecticut, Trinity Health Of New England announced it would host a one-of-a-kind 24-hour Vax-A-Thon event in Hartford. The goal was to serve greater Hartford residents living within zip codes that have been hardest hit by COVID-19 and make up a large portion of the vulnerable populations, with limited access to the vaccine. The intention of the pop-up clinic was to help take strides towards the collective goal of "community immunity" and successfully administered an estimated 3,000 vaccinations.

This event was made possible due to the generosity of JoAnn Price and fellow colleagues from Fairview Capital Partners, LLC. JoAnn serves as Vice Chair on the board of Trinity Health Of New England. When she learned about this opportunity, she worked with her company and raised \$50,000 from three community partners: Fairview Capital Partners, Inc.; Fairview "ALL IN" Fund at the Hartford Foundation for Public Giving; and the JoAnn and James Price Fund for Community Safety at the Hartford Foundation for Public Giving.



"The more people who get the vaccine, the closer we are to doing the things we love again," said Reginald J. Eadie, M.D., M.B.A., President & CEO, Trinity Health Of New England, leading up to the April 2021 event. "We all want to get back to spending time with family, celebrating birthdays and graduations, and going to large public events like sports events or places of worship, and this event and this 'Shot Of Hope' is the way to get back to those things we so deeply miss."

IN MEMORIAM - S. PRESTLEY BLAKE 1914-2021

S. Prestley Blake, co-founder of Friendly's Ice Cream and beloved philanthropist, passed away on February 11, 2021, at the age of 106.

For half a century, S. Prestley "Pres" Blake was an inspiration to the Greater Springfield community and his hometown of Somers as a great benefactor. His influence was broad and deep. Over the years, his countless silent and generous acts of kindness, and tireless encouragement defined the true measure of this great man.

In 2019, S. Prestley and Helen Blake donated \$10 million dollars, the largest gift ever dedicated specifically to Johnson Memorial Hospital, to help carry out a complete renovation of the Johnson Memorial Hospital Enfield Campus. Stuart E. Rosenberg, president of Johnson Memorial Hospital stated, "This extraordinary gift will allow us to establish a newly designed, state-of-the-art facility, complete with all the latest technologies available and enable us to continue to provide optimal care for our patients well into the future."

The plans for the site include the new S. Prestley and Helen Blake Ambulatory Care Center, renovation of the Karen Davis Kryznowek Cancer Center and updates to the grounds and parking facilities at the Enfield location. The Blakes felt very strongly that their gift would have a profound impact on their community for generations to come. Johnson Memorial Hospital was where they received their health care and they knew first-hand how important it was to support its efforts to remain a world-class institution.

We are deeply saddened by his passing but find comfort that his wishes and his legacy will be honored and remembered as we begin construction of the S. Prestley and Helen Blake Ambulatory Care Center.



Planned Giving

Our planned giving societies were established to honor individuals who have left a planned gift to one of our Trinity Health Of New England hospitals – Johnson Memorial Hospital, Mercy Medical Center and its Affiliates, Mount Sinai Rehabilitation Hospital, Saint Francis Hospital and Saint Mary's Hospital. In honor of the year Johnson Memorial Hospital was opened, the 1912 Society was established to celebrate those individuals who have left a gift to the hospital in their estate plan. Although this Society was created just a few years ago, momentum is gaining and they added a new member this past year with a promised gift of \$150,000.

Seeds of Hope Society

The Seeds of Hope Society was established to honor the dedication and vision of the Mercy Founders and continue their good work. Members of the Seeds of Hope Society have named Mercy Medical Center and/or its affiliates as the ultimate beneficiary of a planned gift. The Society was founded many years ago and has more than 300 members.

This past year, the Society welcomed twelve new members with gifts totaling just under \$3 million.

Valencia Society

In 1997, the Valencia Society was founded by former Governor and Mrs. William O'Neill in honor of Mother Ann Valencia, the founding leader of Saint Francis Hospital. With more than 600 members, the society welcomed four new families this past year who carefully thought about how they might help Saint Francis Hospital and Mount Sinai Rehabilitation Hospital continue to serve our patients well into the future.

Slocum Society

More than a century after Right Reverend Monsignor William J. Slocum purchased the land for the future home of Saint Mary's Hospital, the Slocum Society was created to honor his vision and those who pledged a planned gift to the hospital. In the past year, four new members were welcomed with gifts of over \$1 million.
